### Information for parents and families

Dear Parents and Families,

Over the last few days, important decisions have finally been made. In several federal states kindergartens will return to regular operations. The restrictions will end and, in certain federal states, all children will be allowed to come back to their kindergartens and after-school care centres within the next few weeks. As always, you will find detailed up-to-date information about the regulations relevant to the respective federal states on our website that we set up for this purpose. We are all looking forward to seeing the children, whom we have missed a lot during the last weeks.

However, the hygiene regulations and other important precautionary measures to protect your children and our employees will remain. Just yesterday we received the information that one of our children had been tested positive for COVID-19. As a result, all parents, children and employees of that particular centre had to be quarantined the same day. Further tests and risk assessments will follow. This is an experience we want to avoid as much as possible. Therefore, we ask for your patience and understanding that we proceed very carefully when re-opening our centres. We will work in group clusters - depending on the regulations of the respective federal state and in collaboration with the relevant authorities - in which children and employees will then have contact in a controlled way. In these group clusters, we want to enable work scheduling that takes off-peak hours into account and therefore makes it easier to balance work and family life. With this measure, we want to prevent a complete Kindergarten from having to be locked down in the event of an infection.

We also want to remind you urgently: Please do not bring your child to the centre, if he/she has a fever or other cold symptoms. The risk of infection is high and we want to reduce the risk as much as possible.

Please feel free to contact our centre managers if you have any wishes or questions, they will be happy to assist you. This also applies to questions about parent contributions and mealtime costs. Otherwise, please feel


